

Solar panels must not be installed above the highest part of the roof, excluding the chimney. Panels should protrude no more than 200 mm from the roof or wall surface on pitched roofs.

From November 2023, new government regulations also allow solar panels on flat roofs to extend up to 0.6 metres above the roofline without requiring planning permission. This was ...

Roof-mounted panels must not protrude more than 200mm from the roof slope to avoid planning permission. Special permissions are required for listed buildings and properties in ...

The solar panels and their mounting system must not extend more than 20cm beyond the plane of the roof surface. This ensures the panels remain flush and don't disrupt the property's ...

For flat roof installations, panels should not extend more than 1 meter from the roof surface and must not be the tallest feature of the roof, excluding the chimney.
